Surly Snuggnut Chain Tensioner

Hi there. Thanks for spending your hard-earned cash on this Surly product. Surly stuff is designed to be useful and durable. We're confident it will serve you well for years to come.

The Surly Snuggnut is a chain tensioner designed for 12mm horizontal, vertical-slotted dropouts. It keeps your wheel locked in place, while those pesky pedaling forces try to pull it forward. The Snuggnut's design allows fast, easy wheel position and chain tension adjustments without the need for tools (after you've loosened thru-axle bolts, of course).

MARNING: Cycling can be dangerous. Bicycle products should be installed and serviced by a professional mechanic. Never modify your bicycle or accessories. 
NOTES:

- Bent thumbscrews are not covered under warranty. If your thumbscrew is bent, you crashed it or you didn't have your hub properly tightened in the dropouts
- While Snuggnut is compatible with other thru-axles, we recommend using it with a Surly thru-axle. The reason for this is that the indent on the Snuggnut was designed to interface perfectly with the head of the Surly thru-axle. Depending on the size of your thru-axle's head, you may have to run the Snuggnut on the non-fixed side of the thru-axle.

Tools Required


The Snuggnut is a tool-free tensioner. If you have to use a wrench on the thumb screw, in order to tension your chain, something is probably bent or seized. Don't force it, Hamfist. 5mm and 6mm torque wrenches that measure in Nm will be required if using the Snuggnut with a Surly thru-axle. **NOTE:** A 5mm and 6mm torque wrenches that measure in Nm will be required if using the Snuggnut with a Surly thru-axle.

NOTE: For other thru-axles, consult thru-axle manufacturer's installation instructions.



Installation and Adjustment

- 1. With the rear wheel in the frame, remove the axle nut, axle bolt, or quick-release skewer from the rear wheel.
- 2. Slide the Snuggnut onto the thru-axle so the fixed end of the axle nestles into the indent of the Snuggnut.
- 3. Insert the thru-axle into the drive side of the rear wheel and position the Snuggnut so it's butted up against the dropout. It may be necessary to back out the tensioner screw in order to allow the slider to rest against the rear side of the dropout when the hub is in the desired fore/aft position
- 4. Thread the axle bolt and knurled cap onto the non-drive side of the thru-axle, but do not tighten it yet.
- 5. Once the slider is resting against the rear of the dropout, turn the Snuggnut tensioner screw to pull the wheel backwards in the dropout slots. When your chain is properly tensioned and your wheel properly centered in the frame, tighten axle bolt to 16N-m using a 5mm torque wrench.
- 6. When in doubt, consult your professional bike shop mechanic especially if using a non-Surly thru-axle as noted above.
